## NATIONWIDE FRAUD LOSSES TOP \$10 BILLION

The number of reports and the amount lost is up.

(2022: 2.5 million fraud reports, \$9 billion lost) Consumers reported losing more than \$10 billion in fraud in 2023, marking the first time that fraud losses have reached that benchmark, reported by the Federal Trade Commission. This marks a 14% increase over reported losses in 2022.

Below we are going to bullet safer ways to conduct your financial business and not become a statistic. The following are some of the most common current scams: Fake Prize Scam, Fake Check Scam, Tech Support Scams, Romance Scams, Government/Business Impersonator Scams, Grandchild Scams. Some of the details surrounding these types of scams:

• A perpetrator claims the victim has won a nonexistent prize and must send funds to cover the taxes, shipping or handling. They may ask for a credit card or checking account number.

• Someone the member doesn't know sends a check and asks for money or gift cards to be sent back. This happens frequently in conjunction with selling items on Craigslist and Facebook Marketplace.

• A message pops up on your computer or device indicating your account has been locked and you must call a support number for assistance.

• Someone claiming to be the IRS indicates that your Social Security Number has been compromised and you need to verify.

If you have any questions about whether something is a scam or not, please ask us prior to engaging in whatever is being asked. Unfortunately, we have had a couple members scammed out of nearly \$20,000 in the last month. We are here to help safeguard your money.

As always, stay diligent in monitoring all your deposit and credit accounts for accuracy and alert us to any unauthorized activity as soon as possible.
